The Deputy Director, Similipal South Wildlife Division, Baripada, Mayurbhanj, Odisha hereinafter called as 'Authority' on behalf of Governor of Odisha invites tender(s) in two-bid format for **"Procurement of AI Based Surveillance Camera for detecting illegal entry of poachers to Similipal Tiger Reserve/Kuldiha Sanctuary/ Hadgarh Sanctuary"** as per the specification given in the tender as Annexure(s)

### **Scope of Work:**

The scope covers supply of AI enabled Camera alert system, as per given specifications, Documents (Manuals) & Training, and safe delivery to the point of installation. The scope of the work includes:

#### **Component-I**

- i. AI enabled camera traps for use in the forests to monitor poachers, timber smugglers & wildlife.

#### **Component-II**

- ii. Real time data transmission System through Android or iOS application (Camera Alert system).

### **1. Detail Terms and Condition:**

Detailed Terms and Condition for Tender for **"Procurement of AI Based Surveillance Camera for detecting illegal entry of poachers to Similipal Tiger Reserve/Kuldiha Sanctuary/ Hadgarh Sanctuary"** are as under:

#### **A. Technical Bid**

- 1.1 The AI algorithms shall be designed in such a way that it will detect the moving objects in front and give instant alert to the control room through app based system or any other mode on real or near real time basis.
- 1.2 The cameras shall able to work in outdoor environment condition and significantly have more durability while working in the inhospitable environment inside deep forested areas. The cameras and apparatus to be sufficiently have strong water proofing solution to make it function during extremely wet condition.
- 1.3 Camera must be programmed to auto capture any object moving in front of it and enable to segregate human, animals, vehicle and other objects. The camera shall have IR sensor rather than white flash and shall not emit any light while in operation, in order to keep it away from the eye of the poachers and wild animals from unnecessary damage and theft.
- 1.4 The hardware of the camera shall be designed to camouflage in the forest ecosystem to protect it from theft by any unscrupulous & antisocial elements.
- 1.5 The camera shall be ergonomically designed to be fixed in any trees or vertical surface for effective capture.

- 1.6 The camera shall be effectively programmed with software to transmit the real time alert through registered mobile number or through app.
- 1.7 The photographs so captured in the camera shall have date, time & place stamp for record and reference.
- 1.8 The battery life of the camera shall be extraordinarily long in order to avoid frequent replacement in the difficult terrain.
- 1.9 The specifications of the cameras and the warranty of all the hardware are to be indicated.
- 1.10 Technical bid should contain technical details provided along with relevant supporting Documents attached such as technical specifications, technical compliance, and data sheets.
- 1.11 Minimum one years of warranty on the product. Tenderer/Bidder will have to quote for extended comprehensive warranty for the product on expiry of warranty period. However, the contract for extended warranty period will be awarded, if required.
- 1.12 The bidder shall be able to provide assistance for routine servicing/ troubleshooting/ setting/ adjustments etc. to ensure smooth and trouble free working of each camera, other components and the system as a whole during comprehensive warranty. The complete hardware and software support to be extended by the bidder.

#### **B. Financial Bid**

- 1.13 Financial bid(s) of the only technically qualified tenderer(s) will be opened for financial evaluation. Prices should be inclusive of all Taxes & Duties, as applicable. The financial bid(s) will be evaluated on the basis of the total cost as quoted.
- 1.14 Financial bid will be opened day after the technical bidding date i.e. 25.02.2026 at 03.00 P.M in the office of the Deputy Director, Similipal South Wildlife Division, Baripada in presence of the bidder or their representative.

#### **C. General Term & Condition**

- 1.15 The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.
- 1.16 In case of poor quality of the materials detected by the Purchasers, next higher bidder will be ordered subject to satisfaction over the quality of materials as examination by the Purchaser.
- 1.17 The Authority reserves the right to withdraw or relax any of the terms and conditions mentioned above to overcome the problem encountered at a larger scale.
- 1.18 All pre-bid queries have to be submitted in writing to Deputy Director, Similipal South Wildlife Division, Baripada through official email id: [dfo.similipalsouthwl@odisha.gov.in](mailto:dfo.similipalsouthwl@odisha.gov.in) on or before 20.02.2026 by 01:00 PM in the format given below on the letter head of the company.

No queries will be entertained after this allotted time frame. If it is considered necessary to modify the Technical Specifications or any Tender conditions, the same shall be carried out. The modified tender documents will again be uploaded on the website [www.similipal.org](http://www.similipal.org) for the information of all prospective tenderers.

- 1.19 All the pages of the Technical / Financial Bid format shall be page numbered and all the relevant supporting documents as required must be enclosed along with tender.
- 1.20 Payment Terms: 100% payment of the order value shall be released after the receipt of material in good condition at the delivery location and after inspection. No advance payment will be made under any circumstances.
- 1.21 The system should confirm highest standards of the engineering design and workmanship. The system should perform well without much degradation for the service life of at least 5 years from the date of purchase.
- 1.22 The bidder shall supply the complete demand within 30 days from the placement of order.
- 1.23 The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.
- 1.24 By submitting bid application with sign and seal in every page, every bidder shall be considered to have read the "Mandatory Terms and Conditions for technical qualification" carefully & given his consent to abide by the aforementioned terms & conditions.
- 1.25 Quotation/ financial bid should be valid till 180 days from the date of opening of financial bid.
- 2.1 **Termination for Default:** The 'Authority' may, without prejudice to any other remedy for breach of contract, by written notice of default sent to the Bidder, terminate the Contract in whole or in part: If the Bidder fails to deliver any or all of the Goods within the period(s) specified in the Contract, or within any extension thereof granted by the Purchaser; or If the Bidder fails to perform any other obligation(s) under the Contract. If the Bidder, in the judgment of the purchaser, has engaged in corrupt or fraudulent practices in competing for or in executing the contract. For the purpose of this clause: "Corrupt practice" means the offering, giving, receiving, or soliciting of anything of value to influence the action of a public official in the procurement process or in contract execution. "fraudulent practice" means a misrepresentation of facts in order to influence a procurement process or the execution or a contract to the detriment of the borrower and includes collusive practice among bidders (prior to or after bid submission) designed to establish



bid prices at artificial non-competitive levels and to deprive the borrower of the benefits of free and open competition. In the event the Purchaser terminates the Contract in whole or in part, the Purchaser may procure, upon such terms and in such manner as it deems appropriate, Goods or services similar to those undelivered, and the Bidder shall be liable to the Purchaser for any excess costs for such similar Goods or services. However, the Bidder shall continue the performance of the Contract to the extent not terminated. The contractor/bidder shall not display the photographs & content of the work and also will not take advantage through publicity of the work without written permission of the Authority. Non-Compliance to this may result in the blacklisted of firm. The incomplete and conditional tender will be rejected. Quoting unrealistic rates will also be treated as a disqualification.

- 2.2 **Force Majeure:** In no event shall either Party have any liability for failure to comply with this Agreement, if such failure results directly from the occurrence of any contingency beyond the reasonable control of the Party, including, without limitation, strike or other labour disturbance, riot, major power failure, war, natural calamities including but not limited to floods, earthquakes, fire, volcanic eruptions, epidemics, National Emergency, interference by any government or governmental agency, embargo, seizure, or enactment or abolition of any law, statute, ordinance, rule, or regulation (each a " Force Majeure Event"). In the event that either Party is unable to perform any of its obligations under this Agreement because of a Force Majeure Event, the Party who has been so affected shall as soon as may be, after coming to know of the Force Majeure Event, inform the other Party and shall take reasonable steps to resume performance as soon as may be after the cessation of the Force Majeure Event. If the period of non-performance due to a Force Majeure Event exceeds thirty (30) days, the Party whose ability to perform has been so affected may, by giving written notice, terminate this Agreement.
- 2.3 The bidder has to submit the non-refundable tender paper cost of Rs. 10,000/- (Rupees Ten Thousand only) and earnest money deposit of Rs. 1,00,000/- (Rupees One lakh only) which is refundable by way of demand draft only. The demand draft shall be drawn in favour of "**The Deputy Director, Similipal South WL Division, Baripada**" payable at **Baripada**. The demand draft for earnest money deposit must be with the technical bid. Any Technical-Bid found without the Earnest Money Deposit (EMD) will be rejected. The Authority will not be liable to pay any interest on such an amount. The Earnest Money Deposit (EMD) shall be forfeited, if the tenderer withdraws its bid during the period of tender validity. The Earnest Money Deposit (EMD) of the tenderer, whose tender has been accepted, will be returned on the submission of the Performance Security. Earnest Money Deposit (EMD) of the successful tenderer shall be forfeited, if it refuses or neglects to execute the order or fails to furnish the required performance security within the time frame as specified by the Institute. After the award of the contract to the successful tenderer, the Earnest Money Deposit (EMD) of all the unsuccessful tenderer(s) will be refunded within 30 days.



- 2.4 Performance Security PBG (3% of the contract value) should remain valid for a period of sixty days beyond the date of warranty period of the product supplied. The same will be released only after expiration of the validity. The bank guarantee is to be given as per the format attached with this Tender. The successful contractor has to sign an agreement within 7 days from the date of issue of purchase order (PO) on the stamp paper of appropriate value as per format given herein.
- 2.5 The incomplete and conditional tenders will be rejected. Quoting of unrealistic rates will also be treated as disqualification.
- 2.6 Bidder shall not be permitted to withdraw his/her offer or modify the terms and conditions thereof after acceptance of tender. In case the Bidder fails to observe and comply with the stipulations made herein or backs out after quoting the rate, the aforesaid amount of Earnest Money Deposit and Performance Guarantee will be forfeited by the 'Authority'. Besides this, the Bidder will also be liable to be debarred/blacklisted from participating in the tendering process of the 'Authority' in future and/or suitable penalty will be levied.
- 2.7 Normally no extensions of the scheduled delivery or completion dates should be granted except where events constituting force majeure, as provided in the contract, have occurred or the other circumstances demands for.
- 2.8 All the applicable taxes are to be paid by the Bidder/Firm. Price should be quoted accordingly. No price variation shall be allowed during the contract.
- 2.9 On receipt of intimation from the 'Authority' of the acceptance of his/their Tender, the successful Tenderer shall be bound to implement the contract and within 7 days thereof, the successful Tenderer shall sign an agreement and the Schedule of terms and conditions but the written acceptance by the 'Authority' of a tender will constitute a binding contract between the 'Authority' and the person so Tendering whether such formal agreement is or not subsequently executed.
- 2.10 Minimum 3 days of Training Programme needs to be scheduled/arranged by the supplier, without any additional extra charges. The supplier shall provide training with followed by field demonstration at various Wildlife ranges of the Deputy Director, Similipal South Wildlife Division, Baripada for operation and maintenance of the product/system.
- 2.11 Guarantee/Warranty Duly signed and stamped certificate of at least 01year comprehensive onsite warranty as per Annexure-B should be attached with the technical bid. Successful firm will be required to agree for payment of penalty for exceeding permissible downtime during Guarantee / Warranty period.
- 2.12 The material found defective upon opening by the supplier representative in presence of technical committee as constituted by the 'Authority' or not as per tendered specifications will be lifted back at the cost and risk of the supplier from the delivery site.



## 2.13 Arbitration

- a. In the event of failure to carry out the contractual obligations, with in the stipulated period or extended period and determination of the contract for any reason. Violation of the warranties etc. the 'Authority' shall have the right to carry out the unfinished obligation at the exclusive cost and risk of the bidder/firm, after due notice and the difference so accrued shall be recoverable from the bidder/firm.
- b. The provision of the Arbitration and conciliation Act, 1996 or as at relevant time and of rules framed there under and any statutory modifications thereof shall be deemed to apply and be incorporated in this agreement.
- c. Upon every or any such reference, the cost of any incidentals to the reference and award(s) respectively shall be at the reasonable discretion of the Arbitrators or in the event of their not agreeing, of the Umpire appointed the amount thereof or direct the same to be fixed as between solicitors and client or as between parties and shall be direct by whom and in what manner the same shall be borne and paid.
- d. Panel of arbitrators will be provided by the 'Authority' out of which the bidder will have to select one.
- e. The bidder shall have no objection if the officer who has dealt with the case at any stage is nominated as an arbitrator. Further, that one of the arbitrator's shall be Accounts Expert.
- f. In case of vacancy being caused due to resignation, death or incapacity of the arbitrator's to function as such, the same shall be provided in the aforesaid manner and the new arbitrator's shall proceed from the stage at which vacancy is caused.

2.14 All disputes shall be subject to the jurisdiction of the Court of Law at Baripada, Mayurbhanj, Odisha

## 2. Pre-qualification Criteria for Eligible Bidders:

Any false and/or inadequate information can result in rejection of the tender. While deciding on the selection of contractors, emphasis will be given on the design, specification of the product. Decision of the 'Authority' with regard to selection of contractors will be final. The 'Authority' is not bound to assign any reasons thereof. The following are the criteria:

- i. Experience Criteria: The Bidder or its OEM {themselves or through reseller(s)} should have manufactured and supplied same or similar Category Products to any Central / State Govt. Organization /PSU for last 3 years before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the year.
- ii. The bidder shall have registered office in India. The certificate to this effect should be submitted.

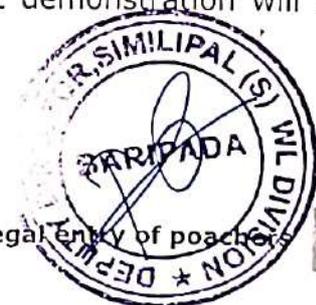


However, preference will be given to the bidder in selection during technical bidding if the bidder have the following criteria;

- i. Who shall have the supply history of same product to any of the state forest department in India and found successful in its operation. Letter or certificate to validate the same to be furnished along with the tender documents.

### 3. Method of Selection

- i. The tender shall be prepared and submitted in two parts, viz, Part-I containing Technical and Commercial details of the offer and consent of the Contractor for terms and conditions of the tender and Part-II containing Prices only (Financial Bid).
- ii. Telegraphic, Fax and E mail tenders will not be accepted.
- ii. Insertions, post scripts, additions and alterations shall not be valid unless confirmed by the tenderers signature. All copies of the tenders should be completed in all respects with all attachments/enclosures/annexures.
- iii. The Authority will evaluate the tenders, strictly on the basis of the terms & conditions incorporated in the tender document with the terms & conditions etc. as stipulated by the tenderer(s) in their tender to determine whether these are compliance in all respects, as specified in the tender document.
- iv. During the evaluation / scrutiny of the tenders, at any stage, if it is found that any of the tenderer(s) terms and conditions are not compliance with tender document, 'Authority' may seek the clarification within the specified target time and if the tenderer fails to reply / or not agree / accept the terms & conditions, their tender will be treated as unresponsive and it is liable for rejection.
- v. Evaluation of the proposals shall be done in two stages as: Technical-Bid/ Evaluation and Financial-Bid/ Evaluation. Technical evaluation of the proposals shall be done on the basis of essential pre-qualification criteria and the required Technical Specification. The Financial-Bid of the only technically qualified tenderer(s) will be opened on fixed date and time.
- vi. A technical committee will be constituted by the authority to scrutinize the bidding documents as per the technical requirement specified in this tender or part of tender documents. The technical committee will also verify the technical specification of the hardware, software as proposed by the participating bidder and select the best with and latest available hardware and software in this segment which will meet the requirement. The decision of the committee will be final and binding upon the parties.
- vii. The participating bidder have to demonstrate their product before the technical committee along with a technical presentation before the technical committee.
- viii. Only bidder with valid documents and products meeting the technical standard of the intended product verified through the product demonstration will be allowed to participate the financial bid.

- Bidder quoted with lowest price (L1) will be awarded with the tender for procurement of AI Based Surveillance Camera for detecting illegal entry of poachers.
- Separate purchase order will be issued by the DFO, Balasore WL Division, DFO, Keonjhar WL Division, DFO, Rairangpur Forest Division, DFO, Karanjia Forest Division and Both of DD, Similipal South WL/ North WL division based on their fund availability on the final quoted price.
- The payment shall be made by the respective DFOs/DDs as per the payment terms subject to availability of funds.

In case there is delay of more than 5 days in attending to a complaint from our side then you can count the number of days in excess of the permissible response time in the downtime.
- iv) We certify that the equipment being offered/quoted is the latest model and that spares for the equipment will be available for a period of at least 5 years and we also guarantee that we will keep the Institute informed of any up-date of the equipment over a period of 5 years.
